- 1. Briefly describe your areas of practice: <u>Response</u>: I am a trial attorney of thirty (30) years experience. I have handled administrative, civil, criminal and juvenile cases before administrative tribunals and at the municipal, common pleas, state court of appeals and Federal Northern and Southern District Court levels. I have also had the honor of arguing cases before the Ohio Supreme Court and the Federal Sixth Circuit Court of Appeals.
- 2. Summarize your experience, if any, before the court to which you seek election: <u>Response</u>: As a trial attorney, I have handled civil and criminal cases before the Cuyahoga County Court of Common Pleas, General Division. As a separate matter, I have also presented criminal cases to the Cuyahoga County Grand Jury at the General Division level.
- 3. Service as judge in state or federal court of record (identify position, court and years of service):

Response: In 1999, I began my judicial career as a Volunteer Magistrate for the City of Cleveland Community Diversion Program for first time juvenile offenders. For eight (8) years thereafter, I would drive up from the Columbus, Ohio area, where I lived, one (1) Saturday a month from September to June. I would begin hearing cases at 10:00 a.m. and not conclude until sometimes around six o'clock in the evening. I received no compensation for this work. Although I was not authorized to place children in the Cuyahoga County Juvenile Court Detention Center, the toughest cases were saved for me to hear. In the eight (8) years that I served in this position, I only had to return two (2) cases back to the Cuyahoga County Juvenile Court.

In 2005, I became an Acting Judge with the Licking County Municipal Court. I served in this position until April of 2007. While an Acting Judge, I was required by the Ohio Supreme Court to attend the Ohio Judicial College for judicial continuing legal education courses.
