This is my sixth year serving as a judge on Ohio's First District Court of Appeals. Since joining the court, I have decided over 1,000 appeals throughout Ohio. I was appointed by Ohio's Chief Justice by special assignment to sit for a case at the Ohio Supreme Court and to sit on the Second, Sixth, Eighth, and Tenth District Courts of Appeals. Prior to joining the court, I advocated for my clients for nearly 20 years, litigating in both state and federal courts. I have represented clients from all over the world and from all walks of life. Some were millionaires, some were impoverished. My extensive legal background includes experience in business and family immigration law, intellectual property, labor and employment, criminal, delinquency, custody and adoptions.

I was appointed by Ohio's Chief Justice by special assignment to sit for a case at the Ohio

Supreme Court. I was also appointed by Ohio's Chief Justice to serve as a commissioner on the

Board of Character and Fitness where we conduct hearings to ensure that applicants possess the necessary character and moral qualifications to practice law as an attorney in Ohio.

- Created Educating Tomorrow's Leaders, an educational and inspirational program for high school, undergraduate, and law students to learn about Ohio's courts, engage with judges, and be inspired to dream big and realize that they can overcome any obstacle. 2017 – Current.
- Created, Organized and hosted the annual Black History Month "Bridge to the Bench," which was created to provide students of color a meaningful opportunity to engage with judges of color. In 2022, the event was a collaboration with the Ohio Black Judge's Association, the Black Law Students Association (BLSA), the Latino Law Students Association (LLSA), and the Asian Pacific Islander Law Students Association (APILSA). - Currently serving on the Board of Beech Acres Parenting Center, whose mission is to empower parents and strengthen children by providing parent enrichment programs, foster parent education and kinship care support and resources.
- As a practitioner, I partnered with various law enforcement agencies to ensure that they understood the issues immigrants and non-English speakers faced in coming to court as a victim or witness, such as the fear of being deported. We developed processes to help ensure attendance at court proceedings. I also provided education and information on law enforcement's role in helping victims of crimes of violence be able to remain in the United States on a victim's visa. One of the largest groups of victims who benefited were domestic violence victims.
- As a practitioner, I worked with juvenile courts to develop internal processes for granting "special juvenile immigrant visas." This visa protects qualified children born in any foreign country from abuse and neglect, by allowing them to remain in the United States under the care of a custodian.
